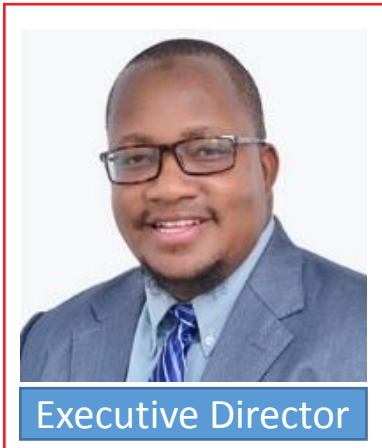

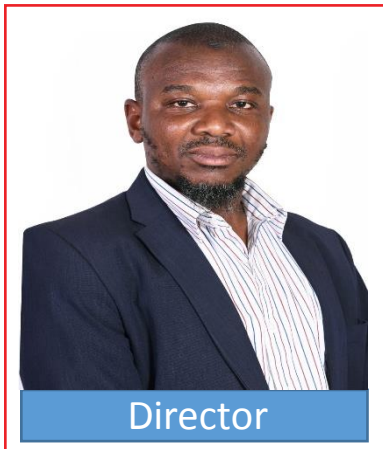
- His attachment to this part of the world has led him to marry an Indonesian lady that has enabled him to access the local language and culture from a closer encounter.
